



# 2019 Tax Return Due Dates



## When is my S-Corporation and Partnership/LLC Return Due?

- S-Corporation Returns are due by 3/16/20.
- S-Corporation Returns that are not complete by 3/16/20 can be extended to 9/15/20.

## S-Corporation and Partnership/LLC Tax Return Appointment Deadline is: February 21st, 2020

- This is the cutoff date that ALL TAX INFORMATION will need to be in our office for us to meet the 3/16 filing deadline. Due to 2018 tax law changes we will not be able to guarantee completion by 3/16 and will complete your return as soon as possible.
- The S-Corporation final filing deadline is 9/15/20 with an extension. To ensure we have enough time to prepare the returns the cutoff date that ALL TAX INFORMATION will need to be in our office for us to meet the 9/15 filing deadline is August 18<sup>th</sup>, 2020.

## When is my Personal Return Due?

- Individual Returns are due 4/15/20.
- Individual Returns that are not complete by 4/15/20 can be extended to 10/15/20.
  - **However, any tax due must be paid by 4/15/20 to avoid interest and late payment penalty charges.**

## Personal Tax Return Appointment Deadline is: March 20th, 2020

- This is the cutoff date that ALL TAX INFORMATION will need to be in our office for us to meet the 4/15 filing deadline. Due to 2018 tax law changes we will not be able to guarantee completion by 4/15 and will complete your return as soon as possible.
- The final filing deadline is 10/15/20 with an extension. To ensure we have enough time to prepare the returns the cutoff date that ALL TAX INFORMATION will need to be in our office for us to meet the 10/15 filing deadline is September 18<sup>th</sup>, 2020.
- This includes Schedule C Tax Returns. (Sole Proprietorships & Single Member LLC's)

**TAX LAW CHANGES: DUE TO TAX LAW CHANGES WE ARE UNABLE TO GUARANTEE COMPLETION OF TAX RETURNS BY 3/16 OR 4/15 FOR 2019. RETURNS RECEIVED PRIOR TO THE APPOINTMENT DEADLINES WILL BE GIVEN FIRST PRIORITY OF COMPLETION. WE WILL WORK TO COMPLETE YOUR RETURNS AS TIMELY AS POSSIBLE. EXTENSION WILL BE AUTOMATICALLY FILED IF WE ARE UNABLE TO FILE BY THE DUE DATE.**
