### When is my S-Corporation and Partnership/LLC Return Due?

- S-Corporation and Partnership/LLC Returns are due by 3/15/21 without an extension.
- S-Corporation and Partnership/LLC Returns that are not complete by 3/15/21 will be automatically extended.

### S-Corporation and Partnership/LLC Tax Return Appointment Window: February 1<sup>st</sup>, 2021 to February 19<sup>th</sup>, 2021

If you wish to have your return worked on for the 3/15/21 deadline, please send your information in during this window and contact your AIC for an appointment. All information should be uploaded using myBBPass. Complete Information that is uploaded during this window will be given priority for the 3/15/21 filing deadline. We cannot guarantee your return will be completed by 3/15/21 even if your information is received during this window. Our capacity to complete returns is based on when your information is received. Your AIC will communicate timing for filing with you.

If an automatic extension is filed for you, your return will have a final filing deadline of 9/15/21. Your AIC will communicate with you prior to this date to ensure your return is filed timely.

### When is my Personal Return Due?

- Individual Returns are due 4/15/21 without and extension
- Individual Returns that are not complete by 4/15/21 will be automatically extended.

**NOTE: If you have tax due, this must be paid by 4/15/21 to avoid interest and late payment penalty charges.**

### Personal Tax Return Appointment Window: March 16<sup>th</sup>, 2021 to March 19<sup>th</sup>, 2021

If you wish to have your return worked on for the 4/15/21 deadline, please send your information in during this window and contact your AIC for an appointment. All information should be uploaded using myBBPass. Complete Information that is uploaded during this window will be given priority for the 4/15/21 filing deadline. We cannot guarantee your return will be completed by 4/15/21 even if your information is received during this window. Our capacity to complete returns is based on when your information is received. Your AIC will communicate timing for filing with you.

If an automatic extension is filed for you, your return will have a final filing deadline of 10/15/21. Your AIC will communicate with you prior to this date to ensure your return is filed timely.

**DUE TO COVID-19 AND TAX LAW CHANGES WE ARE UNABLE TO GUARANTEE COMPLETION OF TAX RETURNS BY 3/15 OR 4/15 FOR 2020. RETURNS RECEIVED DURING THE APPOINTMENT WINDOWS WILL BE GIVEN FIRST PRIORITY OF COMPLETION. WE WILL WORK TO COMPLETE YOUR RETURNS AS TIMELY AS POSSIBLE. EXTENSION WILL BE AUTOMATICALLY FILED IF WE ARE UNABLE TO FILE BY THE DUE DATE.**
