2022 TAX FORMS TO COMPLETE

UPDATED FORMS FOR YOUR 2022 TAX PREPARATION:

We are excited to share with you a new process to gather information we need to complete your 2022 taxes. All information and initial questions we need answered from you will be outlined in our **NEW Web-Enabled Questionnaires**.

These questionnaires are designed to guide you through a series of questions to help us ensure we have correct and accurate information to provide you with the best possible tax outcome.

STEP #1: ENSURE YOU ARE TAX READY

- Before you begin this process, please review the Tax Ready guide we have prepared. It is best to have as much of your information gathered as possible prior to completing your 2022 Tax Questionnaire.

STEP #2 – COMPLETE THE APPROPRIATE QUESTIONNAIRE:

- Each questionnaire is set up to record and send us your answers automatically once you click **SUBMIT**. At the end of each questionnaire, you will be prompted to use your myBBDVault to upload any documents we may need.
- NOTE: Be sure to **SUBMIT** your answers **BEFORE** you upload so you do not lose the information you have answered on each respective questionnaire.

WHAT QUESTIONNAIRE DO I CHOOSE?

- **Individuals:** All personal tax return clients will complete the [2022 Personal Tax Questionnaire](#)
- **Business:** All business returns will need 2 forms completed. The [2022 Business Questionnaire](#) and the [2022 Business Auto & Home Office Questionnaire](#). We will need both forms for EACH business return we complete.
- **Rentals:** All clients with rental properties will need to complete the [2022 Rental Property Questionnaire](#).

STEP #3 – YOUR SUBMITTED ANSWERS AND UPLOADS WILL BE PLACED IN QUEUE:

- After you Submit and upload your documents, your information will be placed in queue to begin preparing your 2022 taxes.
- Your answers and documents will be processed by our staff and then we will reach out to you to set up a meeting to discuss your information and additional items that might be needed.

DO YOU HAVE A TAX FILING DATE REQUEST?

- If you need to have your tax returns completed and filed by a specific target date, please reach out to us **AS SOON AS POSSIBLE** to discuss placing you in the queue.
- Please understand we will do everything possible to meet filing requests, however we may have a capacity limit as we approach certain deadlines.
